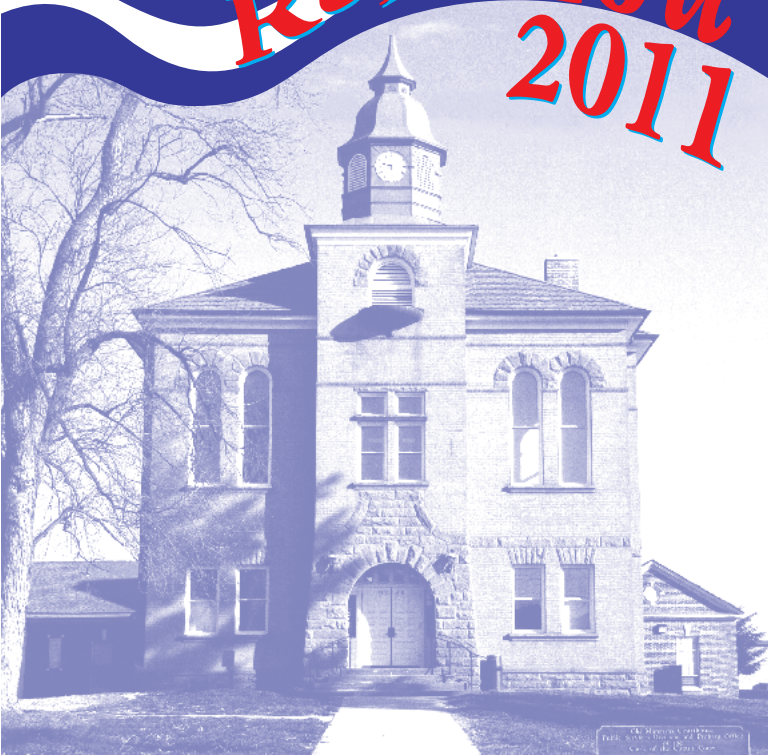

Deadline to register for Statewide Primary ..... August 2  
Statewide Primary Election ..... August 23

**General:** To elect the Commonwealth's Attorney, County Sheriff, Soil and Water Directors, State Senators, State Delegates, all County Supervisors & all School Board Members.

**Deadlines:**

Last day to register to vote ..... October 17  
Request an Absentee Ballot by mail ..... November 1  
Last day to vote absentee in-person ..... November 5  
Election Day ..... November 8

Town of Haymarket: To elect 1 Town Council member.  
Election Day ..... March 8



**Voting Information**

Polls are open from 6 a.m. – 7 p.m. for all elections

Check your voter registration card for your correct voting site. All voters will be asked to provide identification at the polls. Contact your General Registrar for appropriate forms of identification.

You are eligible to register to vote if you are:

- A citizen of the United States
- A resident of Virginia; and
- At least 18 years of age or will be by the next general election

**Voter Registration**

You may pick up a Voter Registration Application from any Public Library and Department of Motor Vehicles Office. For other locations, contact your General Registrar. You can also download and print the Voter Registration Application form from the State Board of Elections website, [www.sbe.virginia.gov/cms/](http://www.sbe.virginia.gov/cms/) or the website of your General Registrar.

**Absentee Voting**

Any registered voter who expects to be away or otherwise physically unable to go to the polls on election day, may vote by absentee ballot.

By Mail: Application forms may be requested from one of the General Registrar Offices listed below or downloaded from their jurisdiction's website. Mailed/faxed applications must be received in the General Registrar's office by 5 p.m. seven (7) days prior to the election day.

In Person: Voting will be available 45 days and up to the Saturday prior to each election or as soon as ballots are received.
